Material Specification

- Construction made of the highest quality laminated, impregnated and double-coated pinewood 90 × 90 mm, secured from the top with polypropylene plugs.
- Metal anchors made of galvanized steel protect the wood from direct contact with the ground, preventing rot and extending the product's life.
- Decks (76 × 76 cm) made of eco-friendly WPC with durable anti-slip and waterproof properties – recyclable, low-emission and gentle on the environment.
- Roofs made of wood, PE or HDPE.
- Slides and crawling tubes made of durable HDPE.
- Moving elements made of durable, weather-resistant PE.
- Net climber and rung ladder made of stainless steel; fireman's pole and challenge ladder also made of stainless steel.
- Safe end caps made of polypropylene provide a smooth, impact-resistant barrier and enhance overall play safety.
- Steel ropes in polypropylene braid, connected with durable plastic or stainless steel elements.

Important Information

- Equipment suitable for individuals with disabilities and designed for public playgrounds.
- The equipment has a certificate from an accredited organization or a declaration of conformity.
- No sharp edges or gaps that could pose a risk of injury to the head, fingers or other body parts.
- The equipment must be anchored on a flat surface.

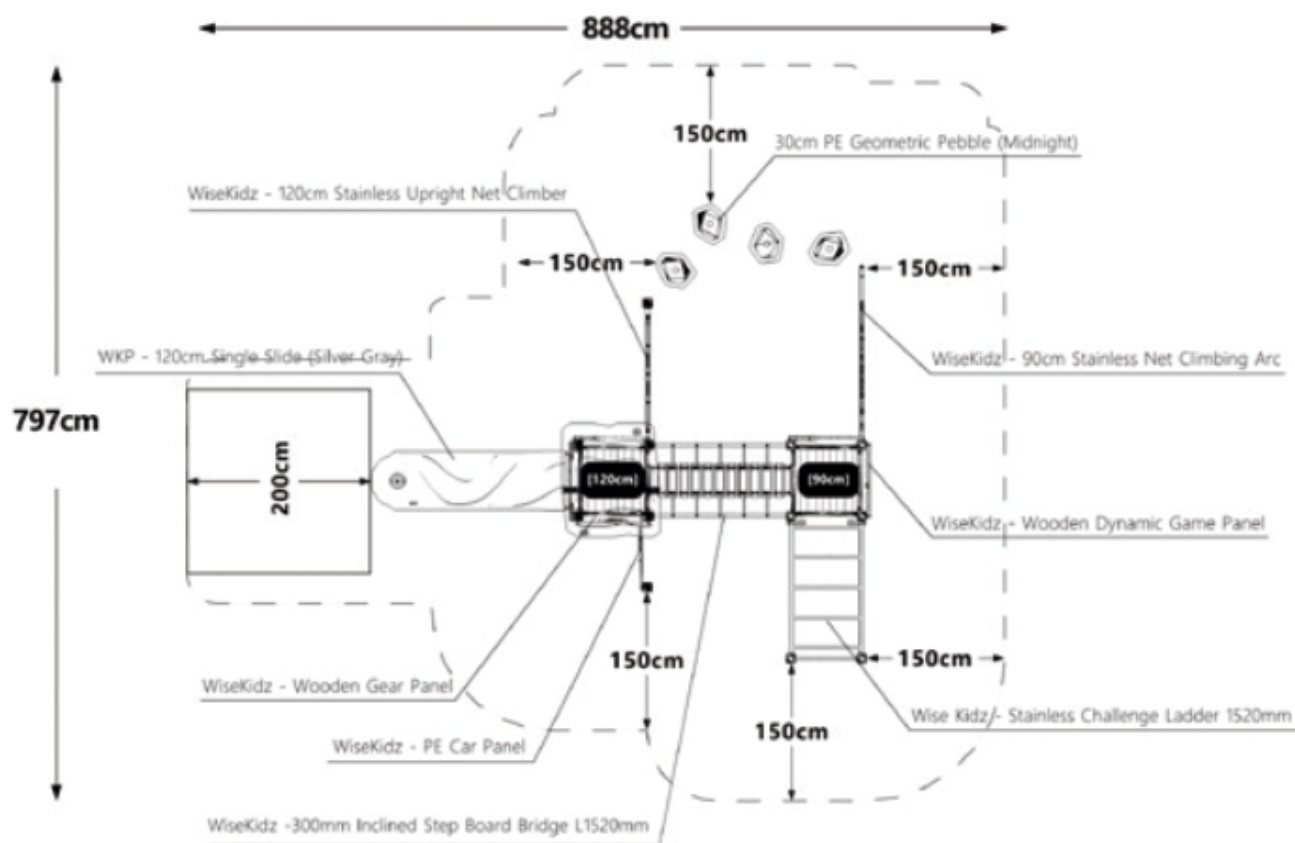

Different views of the play system.

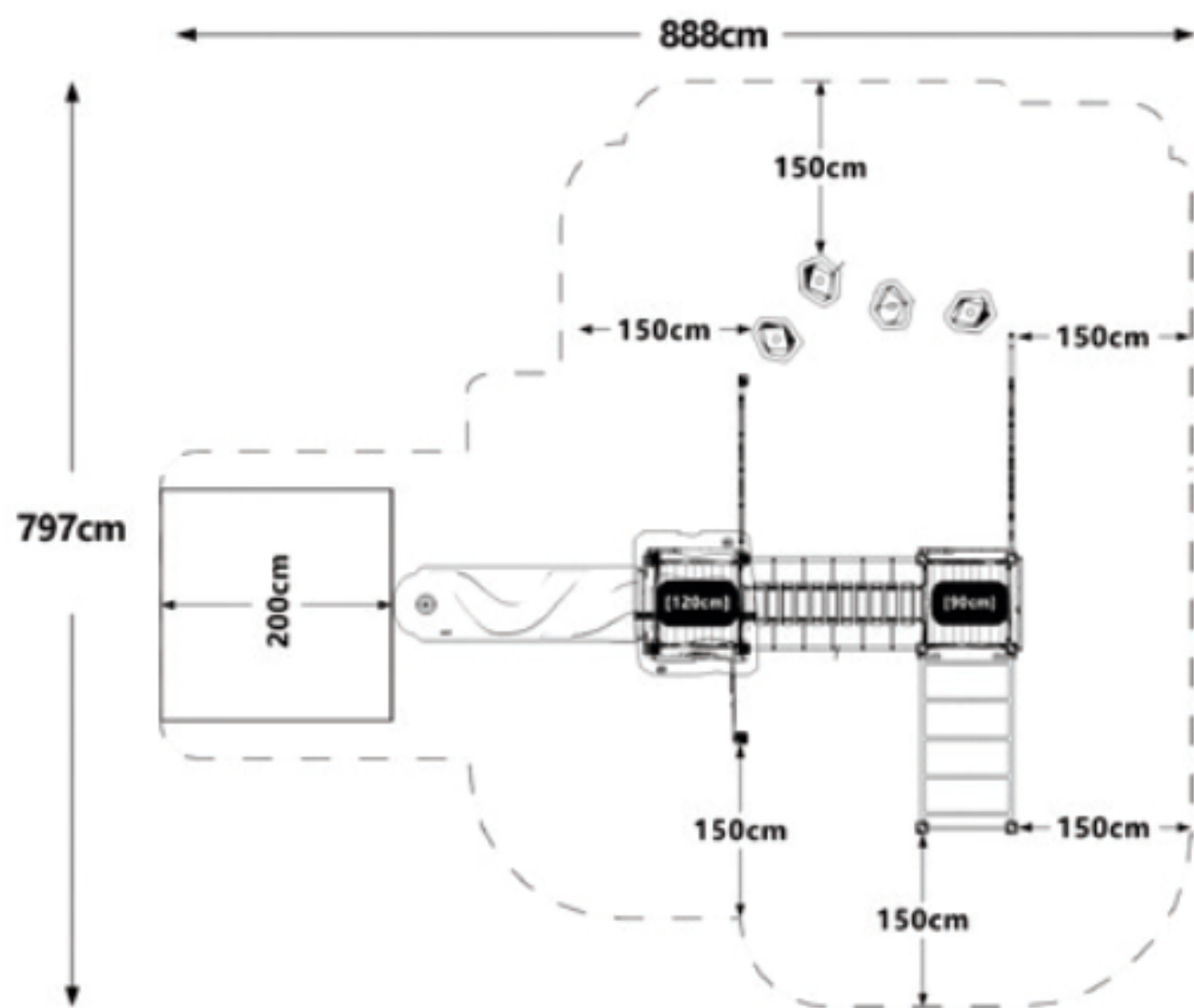


Dimensional Drawing – Play elements

Warranty

15-Year Warranty:

- Robinia wood items against severe rot
- High-pressure laminate panels (HPL)
- HDPE panels (High Density Polyethylene)
- Aluminium parts
- Highly dynamic steel play structures

5-Year Warranty:

- Rope and net constructions
- Graphic print on transparent polycarbonate panels
- Springs used for spring riders and seesaws

10-Year Warranty:

- Pinewood items against severe rot
- Pre-galvanized steel posts with painted top layer
- Painted surfaces on galvanized or aluminium metal components
- Stainless steel slides
- Structural failure of LLDPE parts (e.g. slides, climbing elements)
- Solid plastic items
- Transparent PC (polycarbonate) items
- Wood-plastic composite decks (WPC)

2-Year Warranty:

- Movable plastic and metal parts
- Sunshade structures
- Painted softwood parts with significant coating degradation
- All other items not listed above
